Program Information

A. Yale College Courses for Credit

In person - 2 five-week sessions, A & B offered for Yale College credit in many academic subjects. It has an intense workload due to completing one semester's worth of work (4 months) in 5 weeks, and students need an advanced level of fluency in English, to include reading, writing and speaking. *Proof of English proficiency required.*

For the F-1 student visa: visiting international students taking courses for credit must choose two courses totaling 2 credits during the session they are attending. This is full-time study which is required for the F-1 visa. For students choosing a science course plus a lab (1.5 credits), they'd need to enroll in an additional course to be considered full-time (2.5 credits).



B. Yale College Courses Online

YSS offers online courses for Yale College credit. Online courses are noted with a letter "E". Students who attend in-person may take one online course as part of their two course (2 credit) requirement for their student visa. The second course must be a course taken in-person. If only attending online (from home without traveling to New Haven), a student may take 1 or 2 per session (no visa required). 2 courses is full-time study. Students may choose an online course during the application process. Students won't be allowed to add an online course once the session begins. A short orientation and systems testing happens before the class begins to ensure all students have a proper internet connection and access. Students should be mindful of the time difference, as our courses offer synchronous (live) instruction where students will be required to be part of the virtual classroom to interact with their professor and fellow classmates. *Proof of English proficiency required.*

Tips: Academic advising is available. Contact us for course advice! We admit students on a rolling basis and courses fill up as it gets closer to the start of the summer session. Students should read the course descriptions to select their courses based on interest and academic background (and meeting any course prerequisite).

C. English Language Institute (Session B)

These are non-credit programs designed to help students improve their English and to develop academic and cultural skills that will help them with their academic or professional careers. Each program offered in-person is considered full time study for the purposes of the student visa. Designed for intermediate to advanced level English language learners. Check online for the current program offerings. *Proof of English proficiency not required.*

D. Summer Drama Program (Session B)

The Yale Summer Conservatory for Actors (2 credits) is an acting program taught by faculty trained at the Yale School of Drama.

Proof of English proficiency required.

E. Yale Writers' Workshop

This non-credit workshop brings together the experience and expertise of leading teachers, authors, editors, agents and publishers in a series of panels and workshops for the serious writer. Our faculty provides unique, tailored, and transformative experiences to all participants. *Proof of English proficiency not required.*



FOR ALL SUMMER SESSION PROGRAMS:

Students must live in on-campus housing in order to receive the tuition discount for partner universities.

Students must come to Yale on an F-1 student visa.

A. Course Selection for Yale College Courses for Credit

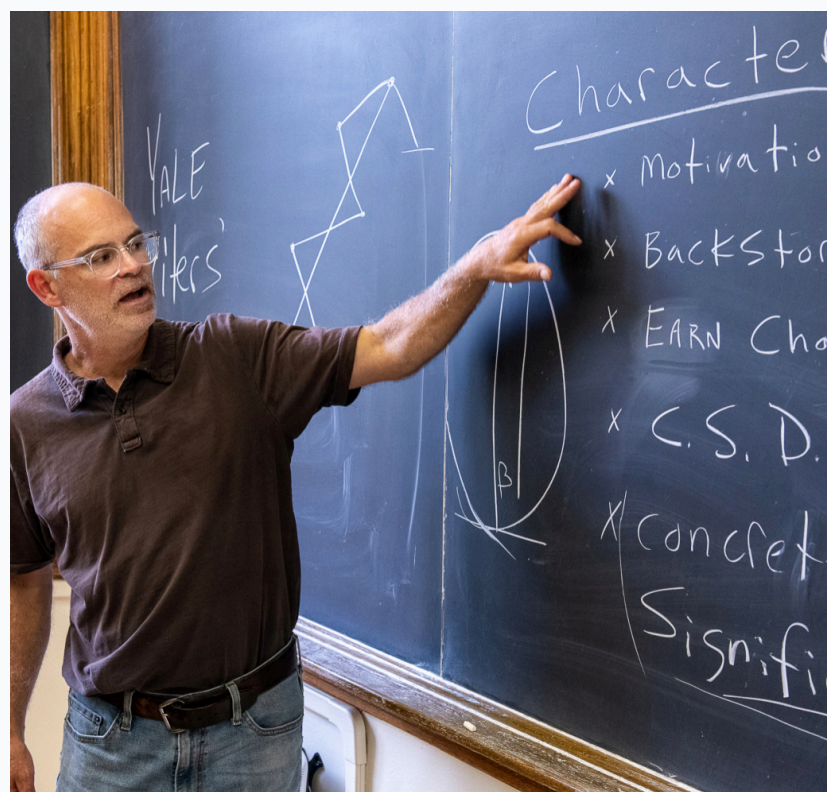
Student success in our programs is our top priority. Students should read the course descriptions carefully to make sure they meet any course prerequisite, and pick the courses they intend to take. There is no guarantee there will be space to accommodate course change requests after the program begins. The course descriptions can be found on our website at:

We hope that students come to Yale to explore new subject matter or attend classes not available in the home university. Because of that, students will not be permitted to take courses they have already taken.



B. Academic Regulations



Because of the requirements of the F-1 student visa, international visiting students attending in-person may not drop a course, audit, receive an incomplete (students must get a letter grade for the course), or stop going to class. If a student is having academic difficulty, he/she should make an appointment with the Dean or Director right away to discuss the matter. There is also STEM and Writing tutoring offered should a student need a tutor in the summer. Class attendance at Yale is mandatory and students must be prepared to make this commitment.

C. Name list

If students are applying through your office, send us a name list so we can monitor the applications. If your students will be applying on their own, no list is necessary. Students will complete and submit their own online application. Based on the student's program choice and if they are attending in-person or online, that will determine what they need to submit. D. I-20s (for in-person study)

The I-20 is a government document that tells the U.S. government that a student is eligible for F-1 Student Status. It certifies that (1) a student is a “bona fide” student; (2) he/she meets our admissions requirements; (3) he/she will pursue a full course of study; (4) he/she proved to us that he/she has enough money to study and live in the U.S. without working illegally or suffering from poverty. We will charge each student a Yale visa processing fee for the I-20. Students will then have to pay their SEVIS fee and apply for their F-1 student visa via the U.S. Department of State website. **I-20s are sent to students by email, using the email they provided in their online Summer Session application.**



After Admission to YSS

Section 3

A. Vaccination & Immunization Requirement

Yale University requires anyone who enrolls at Yale to provide proof of immunizations. Students will not be permitted to stay enrolled in in-person classes until all the forms are submitted and the immunization requirements are met. *Some immunization requirements may take a month or more to complete so early planning is essential.*

Students will be required to upload proof of vaccinations, and then those items need to be verified. Students will be emailed a link and information about where to upload their vaccination records. **Students should attend to the email about vaccinations and immunizations as soon as they receive it to avoid having to switch to online courses or withdraw from Yale Summer Session because they don't complete the process in time.** The deadline to submit materials and be compliant are listed on our website.

B. Health Insurance

All visiting international students, living on campus, who are not U.S. citizens or permanent residents, and who we give an I-20, will be enrolled in and charged an additional fee by Yale Summer Session for a U.S. based health insurance. This is comprehensive health insurance for the duration of the program. Visiting students will also be billed a Yale Health usage fee and may use the Yale Health Center for minor medical problems. C. Student Health

International travel can have an impact on a person's physical and mental health. Encourage students to disclose any pre-existing conditions that they may need an accommodation for either for their academic work or for living in the residential college. The students, after admission and once they set up their NET ID, can register with Student Accessibility Services (SAS) to request these accommodations.

Through their YSS provided health insurance, they will have access to mental health counseling if they need it. They can contact our office for assistance on how to set up counseling using their health insurance, or ask a member of the residential staff.

D. Course Changes & Withdrawing from the Program

If a student needs to change a course or withdraw from the program, they should visit our website at: <https://summer.yale.edu/admitted-students/changes-withdrawals> to review the process to make a change. Once students are admitted, they are considered enrolled in Yale Summer Session unless they fill out the Change Form.

Section 4

A. Transcripts

Students who attended Yale College Courses for Credit may request an official Yale transcript from the University Registrar's Office for a fee. We recommend that students request an official transcript once they can view their grades in the Yale Hub.

Students can request either an e-transcript (PDF) or a paper copy. Because mail service varies around the world, we advise that students order an e-transcript or request courier service (with tracking) to ensure they receive their official transcript. Please review the costs associated with courier service found on the registrar's website. It is most cost effective to request multiple copies of the official transcript at one time (if more than one copy is needed by the student).

B. Certificates

Students who attended a program within the English Language Institute will receive a certificate at the end of the program.

C. Unofficial Grade Reports

During the application process, students from a partner university fill out a grade release form.

Students have the option to report their grades to their home university or choose not to have their grades reported to their home university. For those students, grades will be omitted from the grade report. Please advise your students if it is mandatory that they report their grades back to their home university.

Upon your request and at the end of the session, we can send you the unofficial grade reports for the Yale College courses for credit and English Language Institute. The grade reports are for your office reference only. They are not official Yale transcripts.
